On 14 February 2017, Yanzhou Coal Mining Company Limited (the "**Company**") was approved to issue super-short-term bonds, short-term bonds, medium-term notes and perpetual bonds in multiple tranches during the validity term of 2 years pursuant to the notice of acceptance of registration (Zhongshixiezhushu[2017]DFINo.4) issued by the National Association of Financial Market Institutional Investors. On 26 March 2018, the Company successfully issued the 2018 second tranche of super-short-term bonds (the "**Issuance**"). The amount of the Issuance is RMB1.0 billion and the Company has received such amount by 29 March 2018.
